Identification of market for wholesale provision of terminal segments of leased lines, regardless of the technology used for provision of leased or reserved capacity and designation of JSC "Moldtelecom" as having significant market power on this market

Pursuant to the provisions of Art.9 (1) k), l), m) and u), Art.51 (1) and (2) and Art. 52 of the Law on Electronic Communications no.241-XVI of 15.11.2007, (Official Gazette of the Republic of Moldova, 2008, no. 51-54, Art. 155)

Pursuant to sections 14 and 15 b) of the Regulations on the National Regulatory Agency for Electronic Communications and Information Technology, hereinafter the Agency, approved by Government Decree no. 905 of July 28, 2008 (Official Gazette of the Republic of Moldova, 2008, no.143-144, Art. 917);

Having regard to the provisions of the Regulations on Identification and Analysis of Relevant Markets in electronic communications field and designation of providers of electronic communications networks and/or services with significant market power on those markets, approved by ANRCETI Administrative Board Decision 55 of December 29, 2008,

(Official Gazette of the Republic of Moldova, 2009, no.34-36, Art. 117);

Having regard to the conclusions of the Analysis regarding the identification and review of the market for wholesale provision of terminal segments of leased lines, regardless of the technology used for provision of leased or reserved capacity, the Administrative Board hereby,

DECIDES:

1. The market for wholesale provision of terminal segments of leased lines, regardless of the technology used for provision of leased or reserved capacity shall be identified.

- 2. The relevant product market shall include services of wholesale provision of terminal segments of leased lines, regardless of the transmission links, technologies used and transmission technologies, in the making available of leased or reserved capacity.
- 3. The geographical market for wholesale provision of terminal segments of leased lines, regardless of the technology used for provision of leased or reserved capacity shall cover the on the entire territory of the Republic of Moldova.
- 4. JSC "Moldtelecom", IDNO 1002600048836, shall be designated as a provider with significant market power on the market for wholesale provision of terminal segments of leased lines, regardless of the technology used for provision of leased or reserved capacity.
- 5. The Decision hereby shall enter in force on the date it is adopted and shall be notified to JSC "Moldtelecom" and the Agency for Competition Protection within 3 days.
- 6. The Decision herein shall be published in the Official Gazette of the Republic of Moldova.
