Identifying the market for voice call termination on individual fixed telephone networks

Pursuant to Art.9 p. (1) k) and Art.51 p.(1) and (2) of the Law on Electronic Communications no.241-XVI of 15.11.2007,

Having regard to the Regulations on Identification and Analysis of relevant electronic communications markets and designation of providers with significant power, approved by ANRCETI Administrative Board Decision no. 55 of December 29, 2008,

Having regard to the conclusions of the Analysis for identification of voice call termination on individual fixed telephone networks, **the Administrative Board** hereby

DECIDES:

- 1. The following relevant markets of voice call termination on individual fixed telephone networks shall be identified:
 - Market of voice call termination on individual fixed telephone network of Moldtelecom JSC;
 - Market of voice call termination on individual fixed telephone network of Orange-Moldova JSC;
 - Market of voice call termination on individual fixed telephone network of Arax-Impex LLC;
 - Market of voice call termination on individual fixed telephone network of Riscom JSC;
 - Market of voice call termination on individual fixed telephone network of Sicres LLC;
 - Market of voice call termination on individual fixed telephone network of Sun Communications LLC;
 - Market of voice call termination on individual fixed telephone network of Starnet LLC;
 - Market of voice call termination on individual fixed telephone network

of State Company Special Telecommunications Center;

- Market of voice call termination on individual fixed telephone network of State Company Calea Ferată din Moldova (Moldova railway) ;
- Market of voice call termination on individual fixed telephone network of ITPAY LLC;
- Market of voice call termination on individual fixed telephone network of Cartel-Sistem LLC;
- Market of voice call termination on individual fixed telephone network of Tercom Service LLC;
- Market of voice call termination on individual fixed telephone network of ALIT LLC;
- Market of voice call termination on individual fixed telephone network of Ovatel TDM LLC;
- Market of voice call termination on individual fixed telephone network of Boomtelecom LLC;
- Market of voice call termination on individual fixed telephone network of Eurostock JSC;
- Market of voice call termination on individual fixed telephone network of Unicomtel LLC;
- 2. The network of any provider that could enter the fixed telephony market in the timeframe until the next analysis of the relevant markets for call termination on individual networks shall represent the relevant market for voice call termination on individual fixed network.
- 3. The relevant product market includes all services of voice call termination in individual fixed telephone network provided at the point of interconnection (POI). These services consist of call transportation from POIs to network terminal equipment.
- 4. The national territory shall be the geographical boundaries of every market of voice call termination in individual fixed telephone networks.
- 5. This Decision shall enter in force on the date it is adopted and published in the Official Gazette of the Republic of Moldova.
