### **Approving statistical report forms for providers of public electronic communications networks and/or services**

Pursuant to the provisions of 9 (1) l), s), u), art. 10 (1) e), f), and art. 11 (9) of the Law on Electronic Communications no. 241-XVI of 15.11.2007, the **Administrative Board** hereby

#### **DECIDES:**

1. To approve the sample forms „Statistical Report of a provider of electronic communications networks and/or services”, (hereinafter – Statistical Report), according to [Annex 1](#), [2](#), [3](#), [4](#) and [5](#) to the Decision herein.

2. Providers of the following types of services: local, long-distance and international telephony, including WLL, IP, data transport, Internet access provided at fixed locations, leased lines, facilities associated to fixed networks shall fill in and submit to the Agency:

- a) quarterly (for I and III quarter), through the last day of the month following the quarter under report, regarding cumulative results achieved, according to Annex 4 or 1;
- b) once a semester, through the last day of the month following the semester under report, regarding cumulative results achieved, according to Annex 1;
- c) Annually, before February 15 regarding the situation as per January 1, according to Annex 5.

3. Providers of: mobile telephony, data transport, Internet access Services, provided at mobile locations shall fill in and submit to the Agency:

- a) quarterly (for I and III quarter), through the last day of the month following the quarter under report, regarding cumulative results achieved, according to Annex 4 or 2;
- b) once a semester, through the last day of the month following the semester under report, regarding cumulative results achieved, according to Annex 2.

4. Providers of TV and radio services via fixed/mobile networks, via satellite directly to the user, cable and air TV networks shall fill in and submit to the Agency:

- a) once a semester, through the last day of the month following the semester under report, regarding cumulative results achieved, according to Annex 3.
- b) Annually, before February 15, regarding the situation as per January 1, according to Annex 5.

5. The Statistical Report shall be submitted to the Agency in an electronic form to the address: [raport.statistic@anrceti.md](mailto:raport.statistic@anrceti.md) and in one of the following ways:

- a) by submitting it personally or by a representative of the providers of electronic communications networks and services, under signature;
- b) via postal service in a registered letter with advice of delivery to the address of the Agency: bd. Stefan cel Mare 134, of. 410, Chisinau mun.

6. The preferential reporting form for Annex 3 shall be the electronic one, to the address: [raport.statistic@anrceti.md](mailto:raport.statistic@anrceti.md).

7. Failure to submit the Statistical Report or certain indicators thereof shall be substantially justified.

8. In case of non-compliance with the obligations laid down in s. 2, 3 and 4 the agency shall apply sanctions, as provided by the legislation in force.

9. The Decision herein shall enter in force on the date it is signed.

10. ANRTI Administrative Board Decision no. 02/1 of 04.02.2004 with subsequent modifications and completions shall be repelled.
